



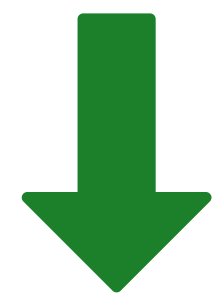

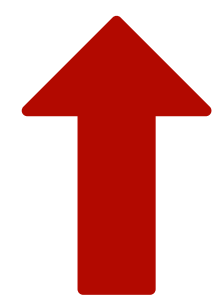

SITUATIONAL ANALYSIS



CRIME

Bogotá closed 2025 with a reduction in eleven of the thirteen high-impact crimes.



PERCEPTION

The perception of insecurity reached historic levels, exceeding **63%**.

This gap reflects a disconnect between operational progress and citizens' lived experience, in an environment marked by the expansion of organized crime, territorial disputes, and the rise of contract killings as a mechanism of control and urban violence.

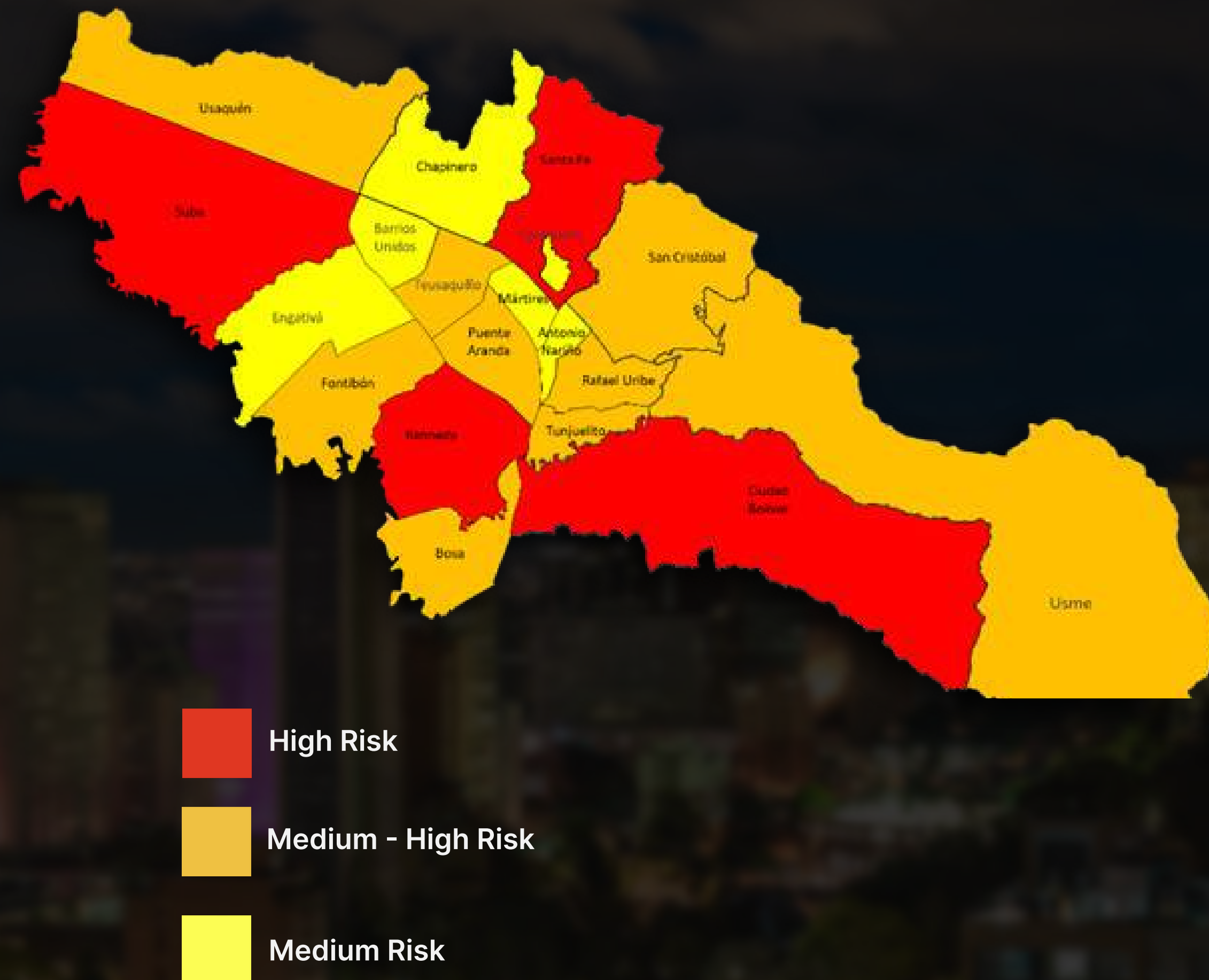

RISK LEVEL

The purpose of the risk level analysis is to identify the localities where, according to institutional statistics, there is a higher probability that violent conditions exist and that high-impact crimes may materialize. The rating for the current Urban Security Assessment – Bogotá 2026 will be conducted using official figures from the District Secretariat of Security, as well as a graphical model developed by the Bogotá Chamber of Commerce (District Secretariat of Security and Coexistence, 2026), covering the period between January and March 2026. Information provided by Councilman Julián Espinosa in his 2025 annual management report will also be considered.

Crime in Bogotá impacts the political, economic, social, and technological spheres, affecting governance, investment, the perception of security, and the digital environment, shaping a comprehensive risk scenario for urban development.
